


# **AAMP Annual Newsletter**

# **News from the Reorganization and Streamlining Committee**

In an attempt to facilitate the approved transition in composition of the AAMP Board of Directors, Resolution 09-I-06 was passed at our 2009 Interim Board of Directors Meeting. The resolution states:

"Per AAMP Bylaws 8.1, the BOD shall schedule an election to be held at the 2009 Annual Business Meeting of two Directors to complete a three-year term in 2012. Additionally two Directors shall be elected at the 2009 Annual Business Meeting to serve a two-year term ending in 2011. The structure of this election is to facilitate the smooth transition of the Board of Directors from twelve to six in number."

Utilizing this approved format will achieve the goal of having at least six Directors and provide continuity of the Directors normally serving a 3-year term with a constant rotation (electing two Directors each year). Our Board of Directors will have eight members in 2010 and six members in 2011 and subsequent years.

# Highlights from the 56th Annual Scientific Session

The 56th Annual Scientific Session was held at the Gaylord Opryland Resort in Nashville, Tennessee on October 25-28, 2008. The meeting was dedicated in memoriam to Drs. Verdi Carsten (Syracuse, NY) and Thomas Cowper (Cleveland, OH). Founded in 1953, the AAMP is an organization dedicated to the prosthetic correction and management of maxillofacial (head and neck) defects acquired from surgical ablation of cancer or traumatic injuries, congenital-birth defects, and alterations in growth and development.

The three day scientific program provided multiple evidence-based lectures, poster presentations, and continuing education courses advancing mainstream concepts and new developments in head and neck surgical oncology, craniofacial reconstruction, and maxillofacial biomaterials and rehabilitation.

Multiple awards were given throughout the course of the meeting. The Andrew J. Ackerman Award, the highest honor of the AAMP, was awarded posthumously to Dr. Thomas R. Cowper for having made Dr. Thomas R. Cowper, 1946-2007. significant contributions to the advancement of maxillofacial prosthodontics.

#### Another Elected to the American Board of Prosthodontics

**Dr. Robert M. Taft** was successfully elected to the American Board of Prosthodontics. Dr. Taft is currently Dean of the Naval Postgraduate Dental School and Director of the Navy Medicine Manpower Personnel Training and Education Command, Bethesda, MD. He joins four other AAMP fellows who are currently serving as Examiners on the Board (Drs. Stephen M. Parel, Jonathan P. Wiens, Rhonda F. Jacob, Steven E. Eckert), as well as Dr. Thomas D. Taylor who is the Executive Director of the Board.

# **Current Research Grants by AAMP Fellows**

*Dr. Zafrulla Khan* from the J.G. Brown Cancer Center in Louisville, Kentucky, is currently carrying out several commercially-funded studies: (1) A Phase III randomized, double-blind, placebo controlled study to evaluate the efficiency and safety of weekly dose of Palifermin (RHukgf) for the reduction of oral mucositis in subjects with advanced head and neck cancer who are receiving radiotherapy with concurrent chemotherapy. This \$199,854.20 study was funded by Amgen and started in April 2006 -Principal Investigator. (2) A Phase II randomized, double masked placebo controlled study on the efficacy of SNX-1012 in reducing the duration and severity of ulcerative oral mucositis in patients receiving crytofoxil chemotherapy for lung, colorectal and breast cancer. This \$30,000 study was funded by Serenex B and started in December 2006 -Co-Investigator. (3) A Phase II multicenter, randomized, double blind, placebo controlled, dose ranging study on to access the safety and efficacy of SCV-07 for the delay to onset of severe oral mucositis in patients receiving chemoradiation therapy for treatment of cancers of the head and neck. This \$42,279 study was funded by SciClone Pharmaceuticals B and started in January 2009 -Principal Investigator.

The Navy research group led by **Dr.** *Gerald T. Grant* in Bethesda, Maryland, has been awarded an additional \$700,000/- for their study in the development and design of direct laser sintered craniofacial implants. This research group and the continued education program will incorporate elements of their research in this year's annual meeting with presentations by the 3dMD company.

**Dr. Fong Wong** from The University of Florida is Principal Investigator for a \$212,555 grant awarded by Neuroanalytics Corp. and NIH NINDS SBIR Phase II (R44NS047863), "Apparatus for testing pain sensitivity in Rodents." It is a sub-contract to develop operant pain sensitivity testing protocols for rodents. Dr. Wong is also the Principal Investigator of a University of Florida Seed Grant Project entitled, "Systemic effects of Cancer on Thermal pain Sensitivity in Mice" for \$10,000. Dr. Wong is also Sub-Investigator for a study entitled, "Functional Elucidation of Aberrant MicroRNA Expressions in Oral Cancer" funded by the University of Florida/ Moffitt Cancer Center for \$100,000/-

**Dr.** *Alvin G. Wee* from the University of Nebraska Medical Center was awarded an NIH / NIDCR K23 award for \$650,000/ from 2006 to 2011, as Principal Investigator. His grant proposal is entitled "Intervention to Prevent Delayed Diagnosis of Oral Cancer." He has also been accepted into the University's Clinical and Translational Research Mentored Scholars Program and will work part-time towards his Ph.D. in his new research focus area of oral cancer delay.

Dr. Alan B. Carr who is Professor at the Mayo Clinic is serving as Dean of the Dental Component of the CMDA/CMDE annual conference, providing CE to dental missionaries in Asia one year and in Africa the next—on a rotating basis. This allows maintenance of U.S. licensure without the cost of travel to the U.S. [total of 42 CE hours].

**Dr. Roger P.
