One of my most notable memories concerns decision-making our executive committee faced on the night of October 26, 2012. Since we were convening for our joint meeting with the International Society for Maxillofacial Rehabilitation (ISMR) in Baltimore, a truly global delegation of participants and attendees had either disembarked for Maryland or were preparing to travel to there. At the same time, Hurricane Sandy was churning toward the mouth of the Chesapeake Bay for what was at the time forecast to be a direct hit upon Baltimore. Following the Governor of Maryland's declaration of an official state of emergency on that evening, an extemporary meeting was held with AAMP, ISMR, RES, Incorporated, and hotel officials.

With the majority of our 2012 executive committee being populated by members from coastal cities who had witnessed the ravages of hurricanes, the 2012 annual session, following a good deal of soulsearching, was lamentably cancelled.

Spotlight on President Elect

Q: Please tell us a little about your personal life, i.e., where you grew up and about your family? What do you enjoy doing when you are not working?

I guess I was destined to become a dentist, my dad being an orthodontist and all. It's just that when the choices came up, I clicked on "circuitous route." I grew up in the Garden State of New Jersey; home of Bruce Springsteen, John Bon Jovi, and Frank Sinatra. My brother the life coach and I were fortunate to have great parents and a



varied upbringing growing up in both suburban and rural areas. Highlights of my childhood included tennis, horseback riding, camping, farming, and even managed to squeeze in a bit of studying ("Gallia est omnis divisa in partes tres..."). College was in Washington, DC during a very tumultuous time in our history, the Viet Nam War was raging. As a political science major in DC at the time, one could not help but be swept into political activism. Also I got to meet a lot famous Americans including Richard Nixon and Ted Kennedy. After college, and still not convinced that dentistry was my calling, I headed to the Great Northwest to work in a legal aid office in Moses Lake, Washington. It was a unique experienced but showed me that the legal profession was not for me. Luckily I had taken my DATs so dental school here I come!

I am fortunate enough not to consider work as work so I don't feel a need to escape but I do have a few non dental interests, including photography, jewelry making, and running (although my knees are beginning to give me some pushback on this). I am also trying to convince people that I am a golfer but not winning over many believers on that front; especially among those brave souls who have played with me.

Q: What training or experiences have led you to become a dentist and eventually a maxillofacial prosthodontist?

My so-called "aha moment" came in my third year of dental school at Case Western Reserve in Cleveland, Ohio (By the way, did you know that Terminal Tower in downtown Cleveland was once the tallest building in the world!) I was sitting in a lecture listening to a recently graduated fellow and as he advanced through his slide presentation that morning, I became hooked on something called, Maxillofacial Prosthetics. Of course, I had never heard the term before but knew instantly that this is what I wanted to do. The young dark haired gentleman giving the lecture that day was none other than our very own fellow AAMP member and past president, Dr. Salvatore Esposito. I became his shadow during my last year in dental school and continue to be grateful to him for his friendship and guidance, even to this day. Plus an added bonus of now getting to call him Sal. I should mention that there were also others who mentored me along the way; Drs. Charles Greene, Louis Fine, and Tom Vergo; yes, that Tom Vergo. To all of them, I am thankful. I must admit is was a bitter pill to swallow for my father to realize I was not going to be returning to 502 Pleasant Valley Way in West Orange to take over his orthodontic practice; especially when it took him years to understand what a maxillofacial prosthodontist does. No matter, he eventually got over the disappointment and I even remember him bragging on occasion about my chosen specialty.

Q: Where do you see our specialty heading? How is the field changing/evolving? Where do you see our future?

Our beloved subspecialty of Maxillofacial Prosthetics is operating in a continuously changing environment. When I applied to a program in 1980, there were 22 from which to choose. Now there are 7. When I went through my fellowship at The University of Chicago (Well, for starters, there was still a program there), when one spoke of implants, you were referring to a bodily area south of the clavicles. Today, there are more and more osseointegrated implants and fewer positions for maxillofacial prosthodontists. And oh yeah, if you haven't noticed, digital technology is taking over our world.

In this shifting landscape, we need to make ourselves more valuable, more marketable to the medical profession and allied health professionals including surgeons, speech and language pathologists and anaplastologists. We should incorporate surgical training including the planning and placement of implants into our fellowship curriculum. Programs such as Jaw in a Day and ART are valuable additions to our tool box to add such value. Familiarity with other jaw reconstruction and microvascular techniques are also valuable. At the same time, we should not neglect congenital conditions of cleft and craniofacial anomalies or trauma. The ability to use digital technology in surgical and prosthetic planning and prosthesis fabrication can also help to keep the maxillofacial prosthodontist in demand. These are areas where our academy can play an important role and add value to being a member. Workshops, locally-sponsored programs and our annual scientific sessions can play an important role in teaching all of us new skills that we must have to be an active participant in maxillofacial rehabilitation. A one year fellowship alone is not enough time to learn all we need to know. In this coming year, I hope to work with our membership and leadership to begin action on some of these ideas.

Q: How do you maintain a balance between your career and personal life?

The short answer to this question is that I don't, at least not consciously. In my career, life seems to ebb and flow between career and personal life not making any clear cut delineation where one ends and the other begins. I guess I'm lucky like so many of you in that the balance just seems to come. Of course, it takes a bit of cooperation from your family members to make this all work. Like, for example when I was studying for my American Boards over a three year period and I was only around on Saturdays to mow the lawn. The neighbors thought I was divorced and only showed up on weekends. But I got through it all with the help of my wife and kids and my success became their success. I think most of you can relate to this as we all have a unique passion for what we do and it spills over to all aspects of our life. Of course, I've changed a few diapers and taken out lots of garbage along the way but then again its all in a days work for a maxillofacial prosthodontist. Speaking while wearing my career and personal life hats, I am pleased and grateful to be president-elect of our academy; a unique group of individuals who provide such life-changing services.
